# 5. Data protection policy

INFORMATION ON THE GENERAL DATA PROTECTION REGULATION

Based on the General Data Protection Regulation, we provide you with detailed information regarding the processing of your personal data by Mercè Corra ONG.

In compliance with this obligation, we inform you of the following:

#### How we have obtained your data

We have obtained your data because of your current relationship with our organization, either because you are a member, have been a donor or have participated in one of our expeditions or campaigns, or because you have requested that we send you information about our activities, expeditions, campaigns and initiatives.

#### What personal data we process

The data we will process for the legitimate purposes explained below are the following:

Data necessary to maintain the relationship with you: name, surname, age, sex, email, telephone, postal address, financial contribution, bank account/card number and NIF.

In the event that you have provided them voluntarily during the relations previously maintained with you, we may also have the following data: family environment, profession, data of the solidarity initiative (place, date, objective, interests), image and voice.

We also inform you that we will treat any additional data that you voluntarily provide us during future relationships and interactions you have with Mercè Corra NGO, including those you provide us through a social network or other application. These data depend on your own privacy settings and use of the social network or application, as well as the privacy policies of each social network or application, so we recommend that you read them carefully before providing data through such social networks or applications.

#### What we use your personal data for

To establish a collaborative relationship with you that makes it possible to meet our founding objectives and we process the data of our partners, donors, collaborators and others who have requested information about our work for the following specific activities:

To fulfill our obligation to our partners, to provide you with all the mandatory documentation that we have by law, in the convening of the assemblies and sending of the general accounts that we submit to official bodies.

Send information about Mercè Corra NGO via SMS, telephone, mail, email or instant messaging.

Request donations, fee increases and other types of participation (signatures during campaigns, etc.) and manage the collection of such fees and / or donations.

Send the tax certificate.

Answer your questions when you contact us.

Invite you to acts or events that we organize.

Conduct satisfaction surveys or organize meetings to conduct market research to help us improve our work.

Manage the relationship with you.

To create profiles, with the information that you have directly provided to us, that you have made public or that is publicly available, in order to ensure the proper management of the activities mentioned above. Profiling is not used, in any case, for the adoption of automated decisions that have legal or other effects that may affect you, in all our decision-making processes involve people.

To manage the promotional activity that you carry out on behalf of our organization.

In addition, we also process your data to send, including by electronic means, communications about activities, campaigns and initiatives of a similar nature to those in which you have participated previously, or about which you have asked us for information or have sent a request to our organization. You may object to receiving such communications, now or at any time, by sending an e-mail to the address of our Data Protection Officer or by sending a request to our postal address, to the attention of the Data Protection Officer.

#### Why we may process your personal data

The legal basis that allows us to process your personal data is based on the following points:

When you decide to support the work of Mercè Corra NGO and/or request to receive information about it, we need to process the personal data you voluntarily provide in order to manage your contributions and/or to be able to inform you properly about the work we do.

Sending your personal information through this website and ticking the acceptance box of this Data Protection Policy implies the express and unequivocal consent to the processing of your personal data in the terms set out above as well as, where appropriate, the sending of informative, promotional or advertising communications by any means, including electronic or telematic means.

Mercè Corra ONG must comply with the corresponding legal obligations, such as, for example, and among others, Law 10/2010 on the Prevention of Money Laundering and Terrorist Financing or the current regulations on the protection of personal data.

For the legitimate interest we have to properly manage your financial contributions, to let you know the existing problems, to comply with our obligations of transparency and accountability and that we can inform you and properly justify the destination of your contributions. We also need to better meet your needs, suggestions and expectations so that we can increase your level of satisfaction as a donor or person interested in the work of our NGO.

These legitimate interests respect your right to the protection of personal data, honor and personal and family privacy. We remind you again that you can object to receive such communications, now or at any time, by sending an e-mail to the address of our Data Protection Officer or by sending a request to our postal address, to the attention of the Data Protection Officer.

When and for what reason we may disclose your information to third parties

Your data may be disclosed to the recipients listed below for the reasons explained below:

Public administrations, for compliance with the legal obligations to which Mercè Corra ONG is subject due to its activity.

Third parties, when necessary to comply with the obligations arising from the campaigns, activities and initiatives in which you voluntarily participate (for example, banks and payment gateway providers).

Suppliers, when they need access to your data for the provision of services that Mercè Corra ONG has contracted with them, and with whom we also have signed contracts of confidentiality and processing of personal data necessary and required by law to protect your privacy (for example, printers).

If in the future Mercè Corra ONG will make other transfers of personal data, we will inform you in a timely manner.

#### How do we protect your data?

Mercè Corra ONG adopts the security levels of personal data protection required by current legislation, installing the necessary technical and organizational measures to prevent loss, misuse, alteration, unauthorized access and other possible risks. We use encryption technologies and methods that allow us to protect the security of the information, as well as the transmissions that can be made through the Internet.

In Mercè Corra NGO only have access to personal data those people who need to use them to perform the tasks assigned to them. It is also reported that is used in the various security mechanisms within the formula of access codes that only know the user and Mercè Corra NGO.

#### International data transfers

Mercè Corra ONG has contracted services of technological suppliers in Senegal, and this country has a regulation equivalent to the European one. These suppliers are obliged to follow the confidentiality and data processing contracts required by the regulations, applying the necessary guarantees and safeguards to preserve your privacy.

#### How long we keep your data

Your personal data will be kept as long as your relationship with Mercè Corra ONG is maintained and, after the termination of this relationship for any reason, during the statutory limitation periods that may apply. In this case, they will be treated for the sole purpose of proving compliance with our legal or contractual obligations. At the end of these periods of limitation, your data will be deleted or, alternatively, anonymized.

#### Your rights

You can exercise your rights of access, rectification, deletion and portability, limitation and/or opposition to the processing by means of the indicated postal and electronic addresses.

Also, if you consider that the processing of your personal data violates the regulations or your privacy rights, you can file a complaint:

To the Data Protection Delegate, at the postal and electronic addresses indicated.

To the Spanish Data Protection Agency, through its electronic headquarters or at its postal address.

### 6. Donations

The donations that you can make through the website are instantaneous and irrevocable, and Mercè Corra ONG will send an email acknowledging receipt and confirmation of the donation made.

If your donation is a monthly fee, following the same procedures, we will send you an email with the acceptance of your fee and we will give you a membership number to be assigned by the system.

Donations can be made through the generation of charges to the account you have provided us, or through the Bizum or PayPal system.

Mercè Corra NGO has CaixaBank as a bank, who will ensure that the entire process of debiting the accounts and crediting the account of the NGO is highly protected with the maximum security measures commercially available in the sector.

Once we have the approval of having taken advantage of the Law 49/2002 of 23 December, donations to the MERCÉ CORRA NGO can be tax deductible (25% for individuals on the Income Tax of Individuals) of the taxable base (35% for companies on the total quota in the Corporate Tax), with a certificate issued by the entity once the donation is made irrevocably and for the general purposes of the same. For this certificate, the donor has to provide us with his full name, his NIF-NIE or CIF, and the province of his fiscal domicile.
